Product Description: Dried sweetened cherries are made from red tart pitted cherries infused with sugar. They are dried to specified moisture, equalized and then packaged. Sunflower oil is used as a processing aid.

Food Safety: All production shall meet or exceed the applicable requirements of the U.S. Federal Food, Drug and Cosmetic Act as amended. Final products approved for shipment shall be produced in accordance with Good Manufacturing Practices under sanitary conditions to minimize the possibility of contamination.

All Cherry Central processing members, co-packers and warehouses are in compliance with the US FDA Bioterrorism and FDA Modernization Act of 2011.

Cherries 70.5%***
Sugar 29.0%
Sunflower oil <0.5%

Dried Cherries are a Gluten free product.


GMO Statement:
