Carton is stenciled with the date of manufacturing, assigned order number and purchase order number as well as the contents. If contents are a mix, the ingredients appear in descending order. If contents are chopped our size symbol will be stenciled on the carton. Net weight shown in lbs. Tests for quality control are run on a regular basis. Specific tests can be run upon request from the customer with appropriate charges applied.

Shelf Life: Cold storage required to insure quality. Store at 32 to 40 degrees Fahrenheit, 1 to 4.44 degrees centigrade. All nut and peanut products are perishable. Unopened product in heat sealed or bulk packaging will retain freshness for 6 months if stored at ambient temperature, 9 months if stored between 32- and 40-degrees Fahrenheit, 12 months if

stored at or below 32 degrees Fahrenheit. Product purchased in a vacuum tin should be stored in a dry area and will retain its freshness for 12 months unopened.
