Whole almonds with desiccated coconut and coconut flavor coated with dark chocolate. This is then polished with a gum Arabic solution and sealed with edible shellac.

### **Lot Coding:**

Each bulk packaged case is labeled with product name, ingredient list, net weight, applicable kosher certification, distributor name/address, and lot number/date code.

Date coding is done in Julian format (DDYY) based off of date of manufacture.

Ex: 06317 = 063 (March 4, 2017). The appearance of a "B" indicates second shift.

Retail Packaged items are coded with a "Best By" date based off of manufactured date in the below format:

Ex: 03/04/17P1 = Best By Date followed by a letter indicating production line, followed by a number indicating shift.

### **Allergen Statement:**

An allergen control program is in place to minimize contamination.

The use of "Soybean oil" in the roasting of all pecans as of October 29, 2018 is stated as "highly refined" from the roasting facility making it exempt from allergen labeling as outlined in the Federal Food, Drug, and Cosmetic Act (21 U.S.C. 321 note).
